Scope and importance of award:



Scope and importance of award:


This is the highest award that NYCCT can bestow on an individual from a business/industry/corporation, or a business/industry/corporation for their partnership and commitment with the local community college.

COMMUNITY COLLEGE INNOVATION AWARD

Scope and importance of award:

This award was established in 2022 to recognize a community college that has introduced a unique idea, project, process or procedure that has resulted in significant improvements in student success.



A New Educational Resource Innovation FINGER LAKES COMMUNITY COLLEGE

FLCC uses both virtual reality and mixed reality in educational programming to provide a more immersive learning environment. In 2018, the College began using three-dimensional holography, called HoloAnatomy, a form of mixed reality to enhance the teaching of human anatomy and physiology, a required class for several

programs. FLCC is the only community college in the nation working with Case Western Reserve on the holography project. Students in the

HoloAnatomy section are more likely to finish the course. FLCC's commitment to using innovative technology to support teaching complex and challenging content helps expand student success in high demand fields.







COMMUNITY COLLEGE INNOVATION AWARD

Honorable Mentions

Fast Track Program MOHAWK VALLEY COMMUNITY COLLEGE



In November 2022, Mohawk Valley Community College launched its Fast Track program-a restorative action to reconnect neglected populations to outcomes through intentionally designed program structures that provide individuals with momentum points of success and multiple credentialing opportunities in extended career pathways. This program attempts to address discriminatory legacy systems and systems lacking equity measures that have allowed too many students to fall through the cracks and never truly reap the benefits of receiving an education. Developed with community-based, user-designed outreach, the College engaged 341 individuals in Fast Track curriculums within the first two months of launch in fall 2022 and remains steadfast in its commitment to expanding programming to meet the needs of the individual, community, and industry alike.



Enrollment Task Force SUNY ORANGE COUNTY COMMUNITY COLLEGE

The Enrollment Task Force created by SUNY Orange's Board of Trustees began in 2020 and will continue. The Task Force has come to understand some of the many reasons for enrollment declines at the College (pandemic related and otherwise) and has supported the College in broadening its enrollment initiatives for both recruitment and retention. The College is hard at work implementing a variety of projects, grants and initiatives that are intended to increase enrollment at the College. Spring 2023 enrollment figures, and early Fall 2023 projects, indicate this innovation is working.
